THIS CHANGE ORDER PROVIDES FOR:

Allowing the contractor to safely operate equipment such as a crane boom (not a suspended load) or concrete pump boom over public traffic upon written approval from the engineer when the work cannot otherwise be reasonably performed.

The tenth paragraph of Section 5-1.04,"Public Safety," of the Special Provisions is amended as follows:

"Suspended loads or equipment shall not be moved nor positioned over public traffic or pedestrians, except the engineer may give written approval for a contractor's request to move or position equipment over public traffic when it is the only practical way to accomplish the work and can be done safely."
