You are directed to make the following changes from the plans and specifications or do the following described work not included in the plans and specifications for this contract. NOTE: This change order is not effective until approved by the engineer.

Description of work to be done, estimate of quantities, and prices to be paid. (Segregate between additional work at contract price, agreed price, and force account.) Unless otherwise stated, rates for rental of equipment cover only such time as equipment is actually used and no allowance will be made for idle time. To meet the Governor's third executive order signed on April 1, 2015 proclaiming a continued state of emergency due to the drought, planned planting work will be delayed until November 16, 2016.

In accordance with Section 4-1.05, "Changes and Extra Work," of the *Standard Specifications*, to address stormwater impacts caused by delaying planting, meet with the engineer and determine modifications necessary to address additional temporary erosion control best management practices that are due to the delayed start of planting work. Modify the Storm Water Pollution Prevention Plan (SWPPP) to address the identified changes. Place and maintain additional temporary erosion control practices due to the delayed start of planting.

Extra Work at Agreed Lump Sum Price:

The following work will be extra work at agreed lump sum price:

- 1. Modification of the SWPPP as necessary to address the delayed planting start date.
- 2. Additional weekly job site stormwater inspections due to contract time extension.
- 3. Additional rain event action plans due to contract time extension.

For this work the contractor shall accept the agreed lump sum price of \$_____. This sum constitutes full and complete compensation including all markups.

Extra Work at Force Account:

For meeting with the engineer to identify changes to the SWPPP the contractor will be compensated on a force account basis.

Use when there are no bid items for required additional temporary erosion control best management practices. Additional erosion control best management practices necessary because of the delay to planting that are identified in the modified SWPPP is extra work at force account.
