The modified SB-1 funding sign will be incorporated into the next update to the <i>California Manual on Uniform Traffic Control Devices</i> . The Division of Traffic Operations issued a Memorandum titled "Modified Senate Bill 1 (SB-1) Project Funding Identification Sign, dated February 1, 2019 mandating that modified SB-1 project funding signs must be installed to replace the existing funding signs on-going construction projects if the project's estimated completion date is after April 15, 2019.
